25-100 Approval of December 9, 2024, City Council Regular Meeting Minutes

Action: Darren Turley made a motion to approve the Minutes. Nancy Williams seconded the motion. 4 Ayes and 0 Nays. Motion carried.

25-101 Approval of December 2024 City Finances

Action: Sammy Moore made a motion to approve the Finances. Jacob Mccullough seconded the motion. 4 Ayes 0 Nays. Motion carried.

25-103 Discuss/Consider/Act Upon complaint to rectify the water service charges at 400 E Blackjack – Mack Stewart, Property Owner

Discussion: Mack Stewart addressed the council about the three-plex he owns. It was addressed by Bobby Mendez according to the Ordinance for multifamily structure and then the council broke Mr. Stewarts bill down for him.

Action: No action was taken.

25-104 Discuss/Consider/Act Upon Texas Wate Development Board Resolution for Financial Assistance- Bobby Mendez, City Manager

Discussion: Bobby Mendez requested approval from the council for a Grant from the Texas Water Development Board to replace a 14-inch line going to the city's water tower.

Action: Dareen Turley made a motion to approve the request. Nancy Williams seconded the motion. The motion passed unanimously.

Discussion: Bobby Mendez presented an updated Drought Contingency Plan for approval from the council.

Action: Darren Turley made a motion to approve the Drought Contingency Plan as presented. Jacob McCullough seconded the motion. The motion passed unanimously.

25-106 Discuss/Consider/Act Upon Reallocation of Development Duties from Code Enforcement to City Manager-Cameron Ray, Chief of Police

Discussion: Chief Ray requested that the 'Developmental Duties' be reallocated to the City Manager as this falls within his duties. He stressed that all Departments would continue to work together on these matters.

Action: Darren Turley made a motion to reallocate the duties to the City Manager's office. Jacob McCullough seconded the motion. The motion passed unanimously.

25-107 Discuss/Consider/Act upon approval of Dublin Police Department Racial Profiling Report 2024-Cameron Ray, Chief of Police

Discussion: Chief Ray delivered the 2024 Racial Profiling Report that revealed no physical force, or profiling complaints had been received during 2024.

Action: Sammy Moore made a motion to approve the Racial Profiling Report as presented by Chief Ray. Nancy Williams seconded the motion. The motion passed unanimously.

25-108 Discuss/Consider/Act Upon Police Department to sign Master Cooperative Purchasing Agreement with the Virginia Sheriffs Association-Cameron Ray, Chief of Police

Discussion: Chief Ray presented to council a proposal for a Master Cooperative Purchasing Agreement with the Virginia Sheriffs Association who host a buy board similar to the one in Texas.

Action: Jacob McCullough made a motion to sign the Master Cooperative Agreement with the Virginia Sheriffs Association. Darren Turley seconded the motion. The motion passed unanimously.

25-109 Discuss/Consider/Act Upon purchase of Mobile Data Terminals for the Police Department through Peacemaker Technologies— Cameron Ray, Chief of Police Discussion: Chief Ray presented a request to purchase Mobile Data Terminals with Grant proceeds from Peacemaker Technologies which is associated with the Virginia Sheriffs Association.

Action: Darren Turley made a motion to approve the request for the purchase of the Mobile Data Terminals. Nancy Williams seconded the motion. The motion passed unanimously.

25-110 Discuss/Consider/Act Upon resolution 1-13-25-2 in Support of FY26 Criminal Justice Grant – Cameron Ray, Chief of Police

Discussion: Chief Ray presented a resolution asking for the council's support of the FY 26 Criminal Justice Grant which would allow the purchase of more radio equipment.

Action: Darren Turley made a motion to approve the resolution. Jacob McCullough seconded the motion. The motion passed unanimously.

Discussion: Bobby Mendez asked the council to extend the contract between the City and Green Creek Water Supply to help Green Creek expand their infrastructure. Action: Sammy Moore made a motion to extend the contract with Green Creek. Jacob McCullough seconded the motion. The motion passed unanimously.
